# **Health Information**

# **Educational Information**

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

• Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

# Definitions

Term	Definition
AL	Action Level: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
Level 1 Assessment	A Level 1 assessment is a study of the water system to identify potential problems and determine, if possible, why total coliform bacteria have been found in our water system.
Level 2 Assessment	A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine, if possible, why an E. coli MCL violation has occurred or why total coliform bacteria have been found in our water system, or both, on multiple occasions.
MCL	Maximum Contaminant Level: The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
MCLG	Maximum Contaminant Level Goal: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

# **Additional Health Information**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. Since you have quite a few customers that have never been inspected, the Department will allow three years to meet the above inspection schedule requirements. You will need to inspect a third of the properties (those that have not been inspected at the required frequency) annually until you are in full compliance by June 1, 2021. (ch. NR810.15 Wis. Adm. Code)		
11. Five dead-end water mains are not being flushed on a regular basis since they do not have flushing devices on them. Solids, film, and bacteria accumulate in dead-end water lines and will result in unsanitary conditions, aesthetic problems, and may result in higher disinfection byproducts if not removed. The Department will allow a multi-year compliance schedule to install flushing devices capable of achieving the 2.5ft/second flushing velocity required by code. The final compliance schedule for correction is June 1, 2021. By October 22, 2018, submit the names of the dead-ends you and a schedule you will begin flushing them. One must be addressed by June 1, 2019, two by June 1, 2020, and the last two by June 1, 2021. (ch. NR810.03,.13(2d), and 811.70(8) Wis. Adm. Code)		10/1/2019
