- 2. Final Report & Invoice submitted for Wisconsin Coastal Management Plan grant for Trail Design & Restoration (in google folder)
- 3. Gil Larsen trailhead improvements update:
  - a. 4 Interpretive Signs being designed by Bayfield Chamber and Visitor Bureau (Paige):
    - i. See drafts in the Google drive: discuss P&R Committee role
    - ii. installation likely to occur in spring
  - b. Bare areas seeded with grass
  - c. North Coast Cycling Association has agreed to contribute a bike rack: discuss location & size
  - d. Upcoming work: 1) expand pad under bench; 2) replenish gravel in steps and along path; 3) replace steps at start of trail (6x6's)
  - e. Defer timber replacement to spring timbers have been ordered (8-12 weeks)
- 4. Big Ravine Preserve Signs: to be ordered in October; installed thereafter
  - a. 2 kiosks to be installed at 1) West Rim Trailhead (behind school); 2) Hilltop Trailhead discuss location
- 5. Grant proposal to DNR for trail construction of 2 connecting trails of the Big Ravine: 1) Pine Bluff; 2) Hemlock Heights pending
- 6. North Ravine Trailhead and north end of the East Rim Trail VERY POPULAR
  - a. Parking area has been constructed
  - b. 2 Trail re-routes constructed
  - c. Gravel placed on wet sections
- 7.Pine Bluff construct late October Early Nov. by Trails Anonymous with volunteers
- 8. Virtual Trails Forum: early December (people expressing interest in donating funds for trails)
