Ordinance No. 396

An Ordinance to amend Chapter 388-Comprehensive Plan of the City of Bayfield, Wisconsin.

The Common Council of the City of Bayfield, Wisconsin, does ordain as follows:

§ **388-1. Authorization**

Pursuant to section 62.23(2) and (3) of the Wisconsin Statutes, the City of Bayfield, is authorized to prepare and adopt a comprehensive plan as defined in section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.

§ **388-2. Public Participation**

The Common Council of the City of Bayfield, Wisconsin, has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by section 66.1001(4)(a) of the Wisconsin Statutes.

§ **388-3. Recommendation by Plan Commission**

The Plan Commission of the City of Bayfield, by a majority vote of the entire commission recorded in its official minutes, has adopted a resolution recommending to the Common Council the adoption of the document entitled "~~2001-2021~~ **2019- 2029** Comprehensive Plan of the City of Bayfield," containing all of the elements specified in section 66.1001(2) of the Wisconsin Statutes.

§ **388-4. Public Hearing**

The City has held at least one public hearing on this ordinance, in compliance with the requirements of section 66.1001(4)(d) of the Wisconsin Statutes.

§ **388-5 Adoption of plan**

The Common Council of the City of Bayfield, Wisconsin, does, by enactment of this ordinance, formally adopt the document entitled, "~~2001-2021~~ **2019-2029** Comprehensive Plan of the City of Bayfield," pursuant to section 66.1001(4)(c) of the Wisconsin Statutes. **The 2019-2029 Comprehensive Plan is an update to the City's 2001-2021 Comprehensive Plan in accordance with s. 66.1001(2)(i).**

This ordinance shall take effect upon passage by a majority vote of the members-elect of the Common Council and publication as required by law.
